## Brevard Judge A.B. Majeed Is New Conference President

**T**he Conference of County Court Judges welcomes Brevard County Judge A.B. Majeed as its President for the 2004-05 term, and Manatee County Judge K. Doug Henderson as its President-Elect.

Nicknamed "Mr. Patriotism" for delivering stirring patriotic speeches about the abundant opportunities America provides, Judge Majeed has declared the primary goal of his term to be increased visibility of all county judges within their communities. He opened his first Conference Board meeting by encouraging all judges to read in schools to increase our judicial public image.

Judge Majeed was elected to the bench as the first minority elected to countywide office in Brevard County, and began his judicial assignment in 1993. He has truly lived the American dream and come a long way from his humble beginnings in British Guyana, South America. His ancestors arrived in British Guyana from India as indentured servants, enduring a treacherous crossing over the "kalapani," or black water, with the promise of a short journey and money to bring home to their families. Born Alli Bakash Majeed in 1947, A.B. was raised with four brothers and two sisters. His parents, neither of whom could read or write, farmed rice paddies in an area so remote it was known as Cinderella, having been left out of everything.

At a young age, Judge Majeed recognized his determination to improve his economic and social position — noting that persons better dressed working in offices were better off than his parents who toiled in heat, mud and sharp blades of razor grass. Political struggle against colonialism and racial division in his country racked his youth, but one miracle which brightened young A.B.'s life was the opening

of a high school in his village. Judge Majeed readily reels off the talented students who comprised the high school's first class — those fortunate to leave Guyana to become successful doctors and businesspersons. In that intensely political environment, in a rigorous school, as the son of a father who served as his village's unofficial ombudsman, Judge Majeed began forming a passion for law and justice.

But the cost was great. His parents worked the fields while he and an older brother attended school. Two of his brothers were denied an equivalent education because the cost was too great before the local high school was built.

"For the first child to make it," he said, "the other children would suffer the consequences."

His high school diploma provided the means to an education which catapulted him to Howard University where he earned the honor of a Phi Beta Kappa key, and thereafter to Catholic University Law School in Washington, D.C.

Judge Majeed began his legal career in Philadelphia where his personal style earned him distinction as a savvy urban lawyer, one who developed a reputation as a smooth talker upon arriving in Brevard

in 1988 to work as a felony prosecutor. He was plucked out of the Orlando Public Defender's office by State Attorney Norm Wolfinger.

Our new president enjoys a reputation as a dynamic public speaker. He has spoken for dozens of community, religious and educational groups in his own county, and enjoys each opportunity as a technique to promote his passionate patriotism, democracy, and Constitutional law.

Judge Majeed is also a popular and dynamic educator, having been a member of the faculty at The National Judicial College since 2001, and presenting many times to our own educational conferences the past 10 years.

A.B. epitomizes the American Dream in every aspect of his professional and personal life. Becoming the leader of the Conference of County Court Judges creates another opportunity for him to enhance the image of the judiciary for all of us.

The Conference is pleased to welcome new Palm Beach County Judge Laura Johnson, an 18-year veteran prosecutor with the 15th Judicial Circuit's State Attorney's Office. Prior to her election to the bench, she served the office as Chief of the Domestic Violence Unit where she supervised a staff of 45. She was also responsible for supervising the DOVE unit, a specialty unit for guiding domestic-violence victims through the criminal justice system by linking them to community services. She also served as Felony Division Chief where she was responsible for the prosecution of first-degree murders, sexual batteries, and habitual felony offenders.

Our new judge was the proud recipient of the 2002 Distinguished Faculty Award, presented by the Florida Prosecuting Attorney's Association. She was an active trainer for police departments and medical professionals in the domestic violence arena.

Judge Johnson dedicated much of her time to community activities such as SafetyNet at Homesafe, a project for victims of domestic violence to receive physical and psychological evaluations. She served as an active member of both the Palm Beach County Domestic Violence Council and Probation Community Service Advisory Board.

During the past year, Judge Johnson has been active in educating the public about our court system. She has participated in the Palm Beach County's "Day at the Courthouse" which educates classes of girls from alternate high schools in the workings of the court system. The girls tour the courthouse, enjoy the wisdom of guest speakers,

and participate in mock trials. Judge Johnson sometimes presides over the mock trials as well as acts the role of counsel.

Judge Johnson obtained her law degree in 1983 from Florida State University School of Law. She is married to Palm Beach County attorney William Johnson. The couple have three children — Robert, Julianne and Caroline.

## Letter from the Editor

## Conference Loses Five Judges in Primary Election

As the trend increases for incumbent judges to draw opposition statewide, our Conference lost five of its judges in the August 31 election. The unofficial results, as reported by the various county supervisors' websites on September

1 reveal that our Conference suffered casualties in Hernando, Miami-Dade, Monroe, Orange and Pinellas Counties.

In Hernando County, Judge **Peyton Hyslop** lost to contender **Donald Scaglione** by a margin of 55 percent to 45 percent. In Miami-Dade County, Judge **Jeffrey Swartz** lost to his contender **Ada Pozo Revilla** by a margin of 48 percent to 52 percent. Also in Miami-Dade, the Conference welcomes new Judge **Judy Rubenstein**, who defeated **Valerie Manno** by a margin of 59 percent to 41 percent.

In Monroe County, Judge **Susan Vernon** was defeated in a squeaker by only 83 votes in favor of her opponent, **Peary Fowler**. There was a recount, but the results did not affect the outcome. Peary is married to a former circuit judge who was defeated. In Pinellas, Judge **Sonny Im**, who was recently appointed, was defeated with 46 percent of the vote by **John D. Carballo** with 54 percent. Also in Pinellas County, **Kathy Hessinger** soundly defeated **Robert Bo Michael** by a margin of 65 percent to 35 percent.

In Orange County, Judge **Jim Glatt** was defeated in a close one by **Mike Murphy**, 47 percent to 53 percent. Also, in Orange, Judge **Deb Blechman** enjoyed a resounding victory to retain

her seat by defeating **Thomas Farrell**, 62 percent to 38 percent.

Our own **Robert Brown** of Holmes County in the 14th Circuit is retiring as of January 6, 2005. A three-way contest for his vacant seat resulted in a run-off between **Owen Powell**, who took 48 percent of the vote and **Tim Wells**, who scored 29 percent of the vote. Also in the 14th Circuit, Washington, County Judge **Colby Peel** enjoyed a victory by 58 percent to 42 percent over **Kerry "Curry" Adkison**.

Although no incumbents in Broward County drew opposition, two seats vacated by retiring Judges **Bill Herring** and **Jerry Pollack** became hotly contested. Broward General Master **Eric Beller** soundly defeated **Robin Moselle** by a margin of 60 percent to 40 percent. And, vying for Judge Herring's seat, **Gisele Pollack** enjoyed a 58 percent victory over opponent **Ellen Feld**, who scored just 42 percent.

In Brevard County, newly-appointed Judge **Rhonda Babb** will enjoy her next six years as a County Court Judge by defeating her opponent, **Benjamin Garagozlo**, 59 percent to 41 percent. And, in Alachua County, a run-off will be necessary between contestants **Walter Green**, who drew 38 percent of the vote and **Emory Springfield**, who carried nearly the same at 35 percent. Also in Alachua, contestant **Tom Jaworski** defeated **Bruce Smith** by a margin of 52 percent to 48 percent.

In Charlotte County, our own Judge **Wayne Woodard** retained his seat by defeating challenger **Carolyn Garber** by a 61 percent to 39 percent margin. In Citrus County, good news for our highly-respected Judge **Mark Yerman**, who soundly defeated his opponent, **Bo Samargya** by a landslide margin of 82 percent to 18 percent.

In Escambia County, two of our incumbent

judges were victorious in their races—Judge **David Ackerman** defeated **Donald Smith** by 71 percent to 29 percent; and, Judge **Patricia Kinsey** defeated **Clint Couch** by 56 percent to 44 percent.

Four races in Hillsborough County resulted in three incumbents retaining their seats and a run-off for the fourth seat. Judge **Charlotte Anderson** defeated **Kim Vance** by 64 percent to 36 percent; Judge **Art McNeil** defeated **Chris Debock** by 57 percent to 43 percent; and, Judge **Paul Huey** defeated **Victor Veschio** by 73 percent to 27 percent. In an open seat, a run-off will be held between contestants **Liz Rice**, who drew 49 percent of the vote and her opponent **Henry Gill**, who took in 26 percent of the vote.

In Lake County, our own Judge **Donna F. Miller** defeated **James Baxley** by a margin of 60 percent to 40 percent. In Santa Rosa County, there will be a run-off between contestants for an open seat between **Robert Hilliard** (44 percent) and **Ken Brooks** (22 percent).

Two years ago, our own County Judge **Preston DeVilbiss** of Sarasota County relinquished his County Court position to run for a circuit seat. He was not successful at that endeavor but interestingly, he has qualified for a county seat this round and will face opponent **Phyllis Galen** (42 percent) in a run-off. He has an uphill battle, taking in only 30 percent of the vote. Good luck, Preston!

And finally, there will be a run-off in Volusia County between contestants for an open seat. **Shirley Green**, who scored 38 percent of the vote will oppose **Brian Toung**, who managed 32 percent of the vote, in the November election.

Congratulations to the winners and good luck to the contenders in the November election!

**Civil Rules Committee**

The Civil Rules Committee met during the July summer educational conference in Naples to discuss several significant actions taken by The Florida Bar Civil Procedure Rules Committee:

1. The Florida Bar Civil Procedure Rules Committee passed the amendment to FRCP 1.510(c) providing that **PRIOR TO A HEARING ON A MOTION FOR SUMMARY JUDGMENT, BOTH PARTIES IDENTIFY THE DOCUMENTS THAT WILL BE RELIED UPON AT THE HEARING.** Our Committee discussed how this amendment will be problematic when pro se litigants fail to file such a document.
2. The amendment to FRCP 1.442, which requires that an objection to a proposal for settlement be made within 30 days from receipt or objections are waived, was passed in concept by the The Florida Bar Committee by a 21-20 vote. Our committee favors such an amendment.
3. The Florida Bar Committee tabled discussions of the proposed amendment requiring that the basis for an award of attorneys fees be pled in both the initial pleading and by motion. Our committee is in favor of such a requirement.
4. Our Committee opposes changes in the Rules to provide penalties for failure to attend calendar calls and the resulting failure to attend trial.
5. Our Committee discussed problems in conducting telephonic hearings. Specifically, the Committee seeks ideas on procedures when a party files a request to appear by telephone at the last minute.
6. Discussions requiring that the Certificate of Service form in FRCP 1.080(f) appear on orders or judgments was tabled at this time.

**Community Service Committee Report**

Suggestions to increase committee activity was discussed at length. Suggestions included:

1. An award to recognize the circuit or a specific judge who has used the vehicle of community service as a creative sentencing technique when court costs are converted to community service hours.
2. A special award to be given to the judge whose referral to a community service agency has led to a new job or made a life-altering experience to the individual.
3. A special award to a judge who has contributed to the community by personally rendering some form of community service.

Additionally, it was recommended that stories or articles related to community service ideas be submit-

ted to the Community Service Committee as a project for next year.

Probation's data on community service continues to be reported at a slow pace. However, the data received shows an increased pattern of community service and the success rate for completion of community service hours is well over 70 percent in some cases.

This data will be provided to Lisa Goodner and other officials to highlight the impact of community service in our state. To date, there are several circuits who have not supplied the requested information. At our Board meeting, Circuit Reps were advised of the missing data and the need to collect and report it as soon as possible. The data received from the circuits will be compiled for the Winter Educational Conference presentation in Amelia Island, January, 2005. Circuits not providing the requested data will be listed as "NO REPORT" received.

**Small Claims Rule Committee Meeting**

The meeting of the Small Claims Rule Committee began promptly at 4:30 p.m. An attendance roster was circulated and all members present were given the opportunity to sign.

The minutes from the prior meeting in West Palm Beach were approved without objection by all members present with no correction to the minutes as written.

Judge Pauline M. Drayton-Harris provided the members with an overview of the Florida Bar Small Claims Rule Committee meeting recently held in Boca Raton, Florida.

**Old Business:**

The Committee briefly discussed the topics to be discussed in the Small Claims Summit as part of the conference to be held in the Winter of 2005.

The collection of the survey on resources available to Small Claims litigants was discussed. Several circuits have responded and the results are being compiled for completion and distribution.

**New Business:**

The committee discussed reconciling the rules and the form for consistency.

Replevin forms were discussed briefly but the committee expressed no major concerns with what is currently being done in this area.

The venue question was discussed in detail and of the judges present no substantial problems were noted, however, there was some discussion on a change of the rule. However, the majority of the committee agreed not to propose a rule change from what is currently being utilized in the rule.

The Committee also agreed to support the recommendation for a Satisfaction of Judgment for Small Claims which is substantially identical to the form used for Civil Judgments.

The meeting was adjourned without any submissions for any new or proposed rules.

The next meeting of the Small Claims Committee will be in January, 2005 at the Conference of County Court Judges Winter Conference.
